2. Financial Report

- -March 2016 Ice Bill: \$14,641.25. March 2015 Ice Bill: approximately \$11,000. That's approximately \$3000 in savings. Year to date: \$7,182 less than last year. *This does not currently include the End of Days event, which ice costs were \$1,160. End of Days event earned \$2,841 in gate fees. Time keepers for this event have not been paid yet. Ann will let Stephanie know the cost of time keepers, to be paid ASAP.
- -Stephanie reported that she would like someone to take over the position of treasure by the end of May 2016. According to Stephanie, the finical records will be send out to a 3rd party auditor by the end of May, and ideally having someone else take it over once it returns would be ideal.
- Stephanie reported that other responsibilities that Stephanie currently taking care of are: registrations, OMHA portal and 3on3 summer league. Melanie agreed to take on registration.

- -Body checking clinic: NMHA will host a checking clinic before the upcoming season. Bret will attempt to schedule the clinic for the first Saturday that we have ice time in the 2016-2017 hockey season.
- -Bret received an email regarding concerns about the way ice time is scheduled. Schedule cannot be made until all the teams are made, and suggestions about shared ice time and other concerns will be taken into consideration at that time.
- -Bret indicated some rumours have been brought to his attention and Brett spoke to the person to dispel rumours. Bret reported that concerns about amount of clinics that NMHA is not offering is concerns. More clinics are being offered by NMHA in the upcoming year.
